

i. Authorization from the Board to enter into a contract with Buchanan Ingersoll and Rooney (BI&R) to represent the PLB in the negotiation of an ARPA contract with the City of Pittsburgh.

VIII. Legislative Updates

a. Tri Party Agreement

An agreement to establish a standard process for the transfer of property from the City of Pittsburgh and URA to the PLB. This amendment is necessary for the Land Bank to begin acquiring property from the City's inventory. Legislation is pending before the City Council.

- a. A briefing was held December 13th for City Councilmembers
- b. Next step: City Council to schedule a public hearing on the amendment to the Tri-Party agreement

b. MCTLL Amendments

MCTLL is an Act that speaks to tax liens and claims on real estate as well as the processes, procedures, and methods by which liens and claims against property can be allowed, filed, and enforced. This amendment will allow the Pittsburgh Land Bank to utilize special powers at Sheriff's Sale.
