A. Tri Party Cooperation Agreement

An agreement to establish a standard process for the transfer of property from the City of Pittsburgh and URA to the PLB. This amendment is necessary for the Land Bank to begin acquiring property from the City's inventory. Legislation is pending before the City Council.

- a. **UPDATE**: City Council scheduled an internal briefing on April 25th at 1PM.
- b. **UPDATE**: Councilperson Gross has committed to scheduling a post agenda and public hearing within the next month.
- B. Municipal Claims and Tax Lien Law (MCTLL) Amendments

MCTLL is an Act that speaks to tax liens and claims on real estate as well as the processes, procedures, and methods by which liens and claims against property can be allowed, filed, and enforced. This amendment will allow the Pittsburgh Land Bank to utilize special powers at Sheriff's Sale.

- a. **UPDATE**: House Bill 711 pertaining to MCTLL amendments will be scheduled for a vote.
- b. **UPDATE**: Senate Bill 202 was voted out of committee on Tuesday, May 9th.
