 - 1. An agreement to establish a standard process for the transfer of property from the City of Pittsburgh and URA to the PLB. This amendment is necessary for the Land Bank to begin acquiring property from the City's inventory. Legislation is pending before the City Council.

- B. Municipal Claims and Tax Lien Law (MCTLL) Amendments
 - 1. MCTLL is an Act that speaks to tax liens and claims on real estate as well as the processes, procedures, and methods by which liens and claims against property can be allowed, filed, and enforced. This amendment will allow the Pittsburgh Land Bank to utilize special powers at Sheriff's Sale.
 - UPDATE: On May 9, 2023, the Pennsylvania Senate Urban Affairs and Housing Committee approved SB202. On May 10, 2023, it was rereferred to the Senate Appropriations Committee.
 - UPDATE: House Bill 711 pertaining to MCTLL passed out of Housing and Community Development Committee. On May 24, 2023, it passed out of committee.
